- **Submission Deadline:** July 9, 2025, at 6:00 PM CT.
- **Edit window:** Edits to submitted abstracts will be accepted until July 11, 2025, at 12:00 AM CT.

Abstract Submission Fee

The fee for Regular Abstracts is \$50.00 USD per abstract.

Abstract fees are non-refundable.

FAQ's

What is the size limit for an abstract?

ANSWER: The size limit (including title and body) is 3,400 characters; this does not include spaces.

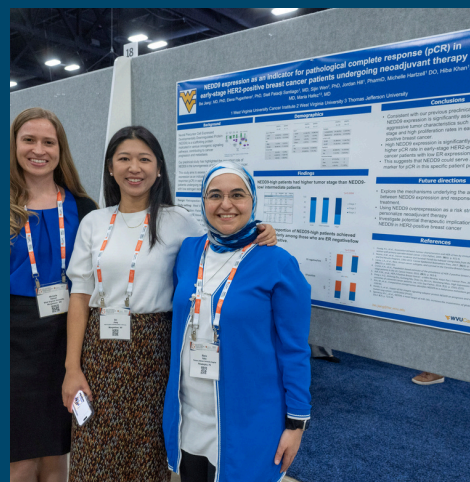
Tables will count as 800 characters against the character limit.

How many abstracts can an author submit?

ANSWER: There is no limit to the number of abstracts an author can submit.

FAQ's continued..

New this year:

Trade Names in Titles are *no longer being accepted*.

Be sure to use only generic names in titles.

The use of tables is permitted.

Late Breaking Abstracts: will be accepted starting September 2, 2025, through September 30, 2025, 11:59 PM CT.

The fee for LBA will be \$100.00 USD per abstract.

Financial Disclosures will be requested upon acceptance.

Are industry/pharma employees allowed to be included as authors/presenters?

ANSWER: Industry and Pharma Reps are permitted to be co-authors/presenters.

Does SABCS allow encore presentations?

ANSWER: The SABCS prohibits the submission of encore presentations **with the exception of clinical trials**. According to SABCS policy, authors must confirm that their abstract data **has not been previously published or presented** at another scientific meeting and will not be published or presented prior to the dates of the symposium.

Clinical Trial Abstract Policy: Clinical trials that have been previously presented **may be submitted** for consideration **only if they contain significant and meaningful new data**. The abstract must **clearly highlight the novel findings being presented**.

Are presenters required to attend the conference in person?

ANSWER: Presenters are *required* to attend in person.

Decision letters will be sent to the Presenting Author early September.

To withdraw an abstract, the presenting author must email sabcs@uthscsa.edu by November 18, 2025, at 12:00 PM CT. Be sure to include the Abstract Title and Abstract Number.
